INTRODUCTION

The Progressive Donor Guide is designed to inform you about the most important races in Washington and help you invest your campaign contributions as effectively as possible. Our goal is to help you support good progressives in the closest races where your contributions can make the biggest impact.

Our Donor Guide highlights our picks for the most important campaigns in Washington to support before the general election.

We give our candidates one of two recommendations: Must Give or Strongly Recommend. The Must Give and Strongly Recommend labels represent the best progressives in the tightest races - our top priority targets.

Our recommendations are focused on the candidates in tough races that need your help to win. That doesn't mean you shouldn't contribute to good progressives who aren't on our list. There are many reasons to support and reward good leaders who don't have the most difficult races, including to cultivate relationships with them. Everyone but those in the safest districts has to run a real campaign this year. If they don't have a competitive race, they are probably "surplus" funds to their caucus campaign committee to support the members who do have tough races, which is critical to winning those races and helps build their influence in the caucus.

POLITICAL LANDSCAPE

2024 is another crucial year for the future of our state and our country. The enthusiasm generated by having Kamala Harris at the top of the ticket is a boost for the whole ballot, and we are optimistic that we can win in Washington and do our part to help save the country with smart strategy and strong work.

The only thing we know for sure about the Presidential race is that it's likely to be terrifyingly close. The electoral college is a tough crowd. Compounding the problem, the odds of defending the U.S. Senate are not good. Democrats must defend 23 of the 33 Senate seats that are up this year and must win at least 22 to maintain control. Two of their seats are in states that Trump won by more than 20 points in 2020 (Montana and West Virginia) and one is in a state he won by over 8 points (Ohio).

The risks in the Presidential race and the challenges with the Senate make it imperative that we flip the U.S. House. The good news is that there's a good chance Democrats can pull that off. The current balance in the U.S. House is 222 Republicans and 213 Democrats, including four Republican vacancies that

have narrowed the margin. Democrats need a net gain of five seats to reclaim the House.

If you want to reclaim the House, defending Representative Marie Gluesenkamp Perez's seat in the 3rd Congressional District (CD) is a great place to start. The 3rd CD in southwest Washington is a +5 Republican district, but Rep. Marie Gluesenkamp Perez upset MAGA Republican Joe Kent by 2,500 votes in 2022 with a big boost from Fuse. Joe Kent is a special forces veteran version of Marjorie Taylor Greene, with aspirations for a national abortion ban. This race is a top priority for reclaiming the House and we owe it to the country to keep Joe Kent out of Congress.

If you are looking for ways to impact the national landscape outside of Washington, our **Battleground States Fund** is a strong option. We've already directed more than \$800,000 to a very compelling set of investments in the most important battleground states that will help flip the House, hold the Senate, and win the presidency. INITIATIVES: DEFENDING PROGRESS

Republican mega donor Brian Heywood has teamed up with the chair of the state Republican Party to put three destructive initiatives on the November ballot that would repeal the biggest progressive legislative wins of recent years: the capital gains tax, the Climate Commitment Act, and Washington’s pioneering long term care program. The Building Industry Association of Washington added in an initiative aimed at blocking efforts to transition away from natural gas. The campaigns against these initiatives will be the biggest and highest profile campaigns in Washington this year and are the progressive community’s highest priority.

STATE LEGISLATURE: DEFENDING AND EXPANDING PROGRESSIVE MAJORITIES IN THE HOUSE AND SENATE

We currently have a strong Democratic majority in the state House (58-40) and respectable margin in the Senate (29-20). But we don’t have a progressive governing majority in the Senate on the toughest issues or on some critical committees. It will be challenging to make real progress on issues like housing and tax reform unless we pick up another progressive vote in the state Senate.

The good news here is that the primary results were very encouraging for state legislative races as well as the statewide executive offices. Progressives are generally on offense, with good opportunities to pick up several more seats in the state Senate and state House.

U.S. District Court Judge Robert Lasnik threw a serious curve ball into Washington’s legislative district lineup last spring when he ruled that the 15th legislative district violated the Voting Rights Act by diluting the ability of Latino voters to elect their candidates of choice. The newly-redrawn, and newly-renamed 14th LD should become a Democratic district, although there are no guarantees this fall. It’s 7-8% more Democratic and contains 2% more BIPOC voters than before. The new maps also make the 17th LD district in Clark County marginally more Democratic, making it more competitive for Democrats. Although the 5th

LD (Issaquah area) is now 2% more Republican, that district has become relatively safer for Democrats in recent years and can handle the hit. The new map makes the 14th a top target for Democrats, who haven’t won a seat in the Legislature east of the Cascades — other than Spokane’s 3rd District — in more than a decade.

Our job this year is to defend our governing majorities in the state House and Senate, and hopefully pick up a few more seats to expand our progressive majorities. We need to defend the seats we’ve flipped in recent years and take advantage of the opportunities to pick up new seats with the recent redistricting ruling.

LOCAL GOVERNMENT: MAJOR IMPACTS IN PIERCE AND SPOKANE COUNTIES

There are outstanding opportunities to make an impact at the local level this year in two of Washington’s biggest and fastest growing counties: Pierce and Spokane counties. There’s also an outside chance to flip the Clark County Council. Flipping control of county governments has huge benefits for the full range of critical issues, including climate pollution, public health, land use and growth management, public safety and criminal justice reform, workers rights, and investments in childcare, human services, housing, and public transit.

TOP RACES

It’s always a challenge to narrow the field of interesting and important races to a reasonable number of “top races” for contributions. In addition to the regressive “Backwards Washington” initiatives and defending Marie Gluesenkamp Perez in the 3rd CD, there are some crucial local races, a large pool of similarly-positioned battleground legislative races, and quite a few new candidates and/or modified legislative districts.

The criteria we use to screen races for our recommendations are: 1) Prioritize opportunities to change the balance of power, 2) Defend the most vulnerable progressive incumbents, 2) Capitalize on pickup opportunities, and 3) Support strong candidates of color and women.



MUST GIVE

MARIE GLUESENKAMP PEREZ FOR CONGRESS

CD3 - Vancouver, southwest Washington



Defending Rep. Marie Gluesenkamp Perez in the 3rd CD is critical to flipping the U.S. House to Democratic control. Gluesenkamp Perez defeated MAGA champion Joe Kent by 2,500 votes in 2022 and will face

him again this year in a Republican district where we can't take anything for granted. This will be a tough race, and we are strongly encouraging investment in Rep. Gluesenkamp Perez's race as well as our independent expenditure backing her.

Why

This race is a top priority for reclaiming the House and we owe it to the country to keep Joe Kent out of Congress.

DEFEND WASHINGTON

VOTE NO ON I-2109, I-2117, I-2124, AND I-2066



Republican mega donor Brian Heywood and his friends have put four deceptive and dangerous initiatives on the November ballot. Together, these initiatives will undo a decade of progress and cut

taxes for big corporations and the wealthy, shifting the bill to middle and lower-income families:

- **I-2109** would repeal Washington state's limited capital gains excise tax, slashing over \$2.2 billion from public education, childcare, and early learning in the next 5 years. It will give a tax cut to fewer than 4,000 of the wealthiest Washingtonians, unfairly shifting the bill to middle-class families.
- **I-2117** is a poorly written and purposely misleading initiative with tremendous costs. Intended to repeal the Climate Commitment Act and end Washington's program to make polluters pay, it would strip billions from Washington's transportation system and jeopardize efforts to fix roads and bridges; threaten our clean water, allow more toxic air pollution and wildfires, and result in more kids and adults with asthma and illness.
- **I-2124** will hurt women and increase our costs and medical debt by eliminating Washington's long-term care insurance program for 3.9 million working Washingtonians. Eliminating these benefits will cause more people, mostly women, to leave their jobs to provide unpaid care, and will increase our out of pocket costs and throw us back into the expensive private insurance market.

- **I-2066** would attack energy efficiency by repealing common sense protections aimed at increasing energy efficiency and promoting the transition to clean energy – leaving us with higher energy costs and making our communities more vulnerable during storms, wildfires, and deadly heat waves. It is part of a nationwide scheme by well-funded interest groups who want to stop the transition to clean energy.

Why

The campaign for all four initiatives is driven by millionaire hedge fund manager Brian Heywood. He wants to roll back Washington's progress and give Washington's wealthiest a massive tax cut at the expense of hard-working Washington families.

There are individual campaigns against each of the initiatives, and **Defend Washington** is the coordinated campaign against the entire slate. Defend Washington is driving up the base "no" vote for all four initiatives to create a firewall of opposition and coordinating across the four No campaigns to increase efficiency and impact.

RYAN MELLO FOR PIERCE COUNTY EXECUTIVE



After finally flipping the Pierce County Council in 2020, we now have a real chance to reclaim the county executive's office as well. The incumbent Pierce County Executive, Republican Bruce Dammeier, is term-limited out.

Progressive Democrat Ryan Mello would make history as the second openly gay county executive in the country. Currently serving as the chair of the Pierce County Council, Mello has impressive experience in local government as well as a strong track record of leadership on environmental, housing, and transit issues. His opponent is Republican Kelly Chambers, a right-wing state representative from the 25th legislative district (Puyallup).

Why

Local governments are where the rubber meets the road for many important issues. Pierce County is Washington's second most populous and one of its fastest growing counties. This race gives us a chance to flip the Pierce County government to Democratic control for the first time in nearly a decade. Dollar for dollar, this race offers one of your best chances this year to make real impacts with your campaign contributions.

MOLLY MARSHALL FOR SPOKANE COUNTY COMMISSIONER DISTRICT 5



Spokane County is controlled by a five-member county commission and doesn't have a county executive. Republicans won the District 5 swing seat on the newly chartered and redistricted commission by 1,507 votes in

2022. That seat is up again this year and we have a great opportunity to flip control of the county government to Democrats.

Republican incumbent Al French is a longtime right-wing commissioner known as a pawn for conservative developers. We have a great opportunity to replace him by electing Democrat and Air Force veteran Molly Marshall this fall.

Why

Spokane County has been controlled by Republicans for at least 20 years. Winning this race would advance issues like criminal justice reform, workers rights, reducing climate pollution, and investments in childcare, human services, housing, and transportation. Dollar for dollar, this race offers one of your best chances this year to make real impacts with your campaign contributions.

MARIA BELTRAN FOR STATE SENATE

LD 14 - Includes Pasco and eastern Yakima County



In March, a federal court redrew the political map in Yakima Valley, creating a new Democrat-friendly 14th legislative district. The new map is 7-8% more Democratic and includes 2% more BIPOC voters, creating a great opportunity for

Democrats to pick up another seat in the state Senate.

Maria Beltran is the former Deputy Director at the House Democratic Campaign Committee. She is running to unseat Republican incumbent state Senator Curtis King. Beltran was born and raised in Yakima, is the daughter of immigrant agricultural workers, and served as the youngest-ever Board President of OneAmerica. Beltran's experience spans all levels of government with a blend of policy and campaign experience, including stints working for U.S. Rep. Kim Schrier and State Rep. Debra Entenman. Beltran's priorities are lowering costs for working people, housing affordability, and championing progressive tax reform.

Why

Picking up another seat in the state Senate would do wonders for our ability to make stronger progress on issues like housing, tax reform, racial justice, and climate change in Washington. As a majority Latino district with low voter registration numbers, winning in the new 14th will require turning out more infrequent voters than any other battleground LD.

DEFEND CD3 INDEPENDENT EXPENDITURE CAMPAIGN

The future of our democracy depends on defending Rep. Marie Gluesenkamp Perez's seat in the 3rd Congressional District. She can't do this on her own - her campaign needs outside help to win. Fuse is organizing an ambitious independent expenditure campaign to defend the 3rd CD. Independent expenditures cannot be coordinated with the candidate and are not subject to contribution limits.

Our plan to defend the 3rd CD emphasizes:

- Strong turnout among infrequent progressive voters is essential to our success. Our comprehensive Get Out The Vote program includes extensive campus-based organizing; targeted community-based organizing; and phone and mail programs.
- A cutting edge and highly-targeted digital video campaign that reaches swing voters with the messages and messenger they need to hear to make the right decision in this race. Our research shows that swing voters move away from Kent when they learn about his political extremism and support for a national abortion ban. Positive messages about Gluesenkamp Perez's work to lower prescription drug costs, expand educational opportunities, and defend reproductive freedom are also persuasive.
- Our digital ad campaign started with an emphasis on increasing Gluesenkamp Perez's positives with swing voters to inoculate her against the flood of attack ads coming her way. Now we are focused on Kent's biggest vulnerabilities: that he supports banning abortion and prioritizes extremist partisan nonsense over the real challenges facing working people.

Why

Winning this race is critical to flipping the U.S. House and ensures we keep MAGA extremist Joe Kent out of Congress so we can protect our democracy, women's rights, our planet, and much more. Gluesenkamp Perez needs outside help to overcome a flood of conservative attacks and a complex political climate in a Republican district.

JANET ST. CLAIR FOR STATE SENATE

LD 10 - Island County, southwest Skagit County, and northwest Snohomish County



Island County Commissioner Janet St. Clair is challenging Republican incumbent Ron Muzall. The 10th is a conservative-leaning swing district but St. Clair is a perfect fit for the district, and Muzall's weak performance in the primary

shows St. Clair has a real opportunity to flip this crucial state Senate seat. St. Clair has a broad constituency across the district and was the Executive Director of the environmental nonprofit Sound Water Stewards of Island County, served on the County Health Board, and has been an Island County Commissioner for the last five years. St. Clair's priorities are to lower costs for working families, protect clean air and water, and defend reproductive rights.

Why

Picking up another seat in the state Senate would do wonders for our ability to make stronger progress on issues like housing, tax reform, racial justice, and climate change in Washington.

ADISON RICHARDS FOR STATE HOUSE

LD 26 - South Kitsap County and northwest Pierce County



Republican Rep. Spencer Hutchins is stepping down after one term. Democrat and lawyer Adison Richards is running for this seat again after losing to Rep. Hutchins by less than 1% in 2022. His opponent is Jesse Young, a former state representative and far-right

MAGA Republican who repeatedly introduced the most hardline anti-abortion legislation in his time in the Legislature and was also repeatedly sanctioned for mistreating his legislative staff. Richards is running to lower the cost of living for working families, address the homelessness crisis, and protect reproductive freedoms.

Why

Winning this seat would help maintain a progressive majority in the state House, and keep a leading MAGA abortion ban supporter out of the Legislature.

MARLA KEETHLER FOR STATE SENATE

LD 17 - Eastern Vancouver and southwest Clark County



Special education teacher Marla Keethler is running for the open Senate seat in the 17th legislative district against incumbent GOP Rep. Paul Harris. The new 14th LD map in central Washington makes the 17th legislative district in Clark County marginally more

Democratic, and Keethler's near tie in the primary with her opponent demonstrates it is possible for Democrats to compete in this district for the first time in many years.

Why

This could be a great opportunity to pick up another seat in the state Senate.

SAL MUNGIA FOR STATE SUPREME COURT POS. 2



Sal Mungia is a progressive, highly respected, and accomplished attorney running for the open Position 2 seat on the Washington State Supreme Court. The rare open seat was vacated by Justice Susan Owens, who has to retire this year because she turned 75 in

August. His opponent is an anti-abortion Republican. Supreme Court races are tough to fundraise for, and candidates struggle to generate the funds needed to reach voters. An unusual name is a disadvantage. Mungia didn't perform as well in the primary as we'd hoped, earning only 43% of the vote. The vote share amassed by right-leaning candidates in the primary was 52.75%.

Why

In a low information, nonpartisan State Supreme Court race, voters struggle to decide who to vote for. Mungia needs significant funds to get his message out to a statewide electorate. This race is a great opportunity to support a progressive, pro-choice candidate and keep an anti-abortion conservative off of Washington's highest judicial bench.

JANI HITCHEN FOR PIERCE COUNTY COUNCIL DISTRICT 6



Democrat Jani Hitchen is a former high school science teacher running to retain her seat on the Pierce County Council. Hitchen won her seat in 2020, flipping the Pierce County Council to Democratic control. Her opponent

is Republican Loujanna "LJ" Rohrer, a Senior Legislative Assistant for the Washington State House of Representatives and the current school board member for the Steilacoom Historical School District. Rohrer currently holds a significant fundraising lead in the race. This is Hitchen's first re-election campaign, and she performed worse than expected in the primary election.

Why

We have to defend this seat to maintain a Democratic majority on the Pierce County Council.

WHY TO GIVE

We believe there are six basic reasons to make campaign contributions:

SAVE THE COUNTRY

The rise of far right-wing extremism in this country is deeply sinister and concerning. MAGA Republicans and white supremacists are attacking democracy, rolling the clock backwards on women's health and other issues, while promoting racism and violence. We run the risk of losing ground on all of our policy advances if far-right Republicans win, and with so much at stake in every one of these elections, every donation to support progressive candidates is a tangible and impactful way to fight back against rising MAGA extremism.

HELP GOOD PEOPLE WIN

We believe the top priority is to support good progressives in close races who need your contribution to win.

REWARD PROGRESSIVE LEADERSHIP

Good people who provide strong leadership and take political risks deserve our support. They generate enemies and opposition with good votes, and if we don't support them it sends a powerful negative message to other legislators.

BUILD RELATIONSHIPS

Contributions can build personal political capital with your elected officials, making you a more effective lobbyist for progressive causes.

DEFEAT CONSERVATIVE LEADERS

Take out incumbents or challengers who are real obstacles to progress.

ACHIEVE OUR POLICY GOALS

Whether your goal is to strengthen laws that fight carbon pollution, create a more equitable tax system, or increase funding for education, investing in the races that build a governing majority aligned with your goals is the key to our success. We don't recommend contributing more than a nominal amount to a non-competitive race unless you are working to strengthen or maintain a relationship with the candidate.

HOW & WHEN TO GIVE

In person: We recommend making contributions at events or in person where you can make a personal connection with the candidate. This way, you can communicate your concerns and priorities to a candidate when you make a contribution.

By mail: If you can't contribute in person, we recommend that you mail them a check with a note, telling them you are supporting them because they were recommended in the Fuse Progressive Donor Guide. Sending them a check eliminates the credit card company's cut (which adds up) and allows you to add a message to your contribution.

Online: If you can't donate in person or by check, donating online is a good option.

Independent Expenditures: Most legislative races now have substantial independent efforts to bolster good candidates. Independent expenditures cannot be coordinated with the candidate, and are not subject to contribution limits. We are happy to provide insight and guidance about specific races and independent expenditures if you are interested.

SAMPLE BUDGET

Our recommendation levels are based on a sample budget and the level of contribution that is significant for a given type of race. Contribution limits are generally per election and are 50% lower after the primary election. For a state legislative or local race, they are now \$1,200 per person (\$2,400 for a married couple). For a Congressional race the limits are now \$2,900 per person. If you have the ability to make larger contributions than the ones outlined in these budgets, please do so! We are happy to provide advice and recommendations for larger budgets.

Our sample budgets in the primary reserved half of your contribution budget for the general election. Full disclosure – these budgets are larger than the funds that we recommended reserving for the general in our sample budgets. They offer a relative prioritization of the races for a budget of any level.
